



## CAPA 50<sup>th</sup> Anniversary 12-Month Member Giveaway

### Official Terms & Conditions

#### Eligibility:

The CAPA 50th 12-Month Member Giveaway (henceforth referred to as the “Giveaway”) is open to active members of the California Academy of Physician Associates (CAPA) that are in good standing at the time of each monthly drawing. CAPA membership must be valid and current to qualify.
